## SIGN UP EARLY FOR BEST SELECTION

All reservation and space requests will be considered on exhibit space utilized at previous conferences, the character of the proposed exhibit, preference as to location, and date application is received. Every effort will be made to assign exhibit space according to preferences indicated on the application; however, preferred choices cannot be guaranteed. Early sign-up provides your greatest likelihood of obtaining preferred space.

## BOOTH FACILITIES

Perimeter booths will include a draped back wall, 3 or 8 foot high x 10 feet wide; two draped side walls, 3 feet high by 10 feet wide; and a custom-made sign identifying the exhibitor. The entire Exhibit Hall is carpeted; however, exhibitors may wish to provide (or rent) booth carpet to match colors of their exhibit. A detailed exhibitor information package will be mailed to exhibitors.

## EXHIBITOR LIABILITY AGREEMENT
