### In **1990's**,

The beginning of coastal/ecosystem restoration/dredging in Louisiana these were considered big:


- 5 miles of 30 inch dredge pipe, no booster pumps;
- 100 acres of marsh and dune creation;
- 1-2 miles barrier island;
- \$ 20-25 M projects with one funding source;

### In **2014**:


- 22 miles of 30 inch dredge pipe, 4 booster pumps;
- 1<sup>st</sup> hopper dredge project in 2013;
- 1<sup>st</sup> use of Ship Shoal in 2013 (20+ miles offshore);
- 500 + acres Marsh and Dune Creation;
- 3-5 miles barrier island;
- \$ 80 100 M +;
- Multiple funding sources; Combining projects for efficiency;
- 1<sup>st</sup> dredging from Mississippi River 2010, now 5
- 1<sup>st</sup> dredging from Mississippi River to -70 NAVD, now to -90 NAVD;
- 1<sup>st</sup> use of electric booster pump;



- Provide an access corridor (13 miles) that can be reused on future restoration projects.




## General Extent of LDSP and other Projects





# **Permit Conditions**

- Ensure 500,000 cubic yards (cy) are always available above elevation -70 NGVD, within the Alliance Anchorage Borrow area for the sill.
- If USACE issues contract to construct the sill, Contractor can bid on sill.
- If awarded Contractor shall stop work on project and construct the sill.
- If contractor not awarded, shall suspend project work and move off site so as not to interfere with or delay the USACE notice to proceed or the sill contractor's work.
