CALL FOR PAPERS

We are pleased to make the First Call for Papers for the 2020 Dredging Summit & Expo. The technical sessions at our annual Dredging Summit and Expo are the premiere venue to discuss the science and practice of dredging. Interested authors and presenters are invited to submit abstracts online at WEDA's dedicated conference website www.Dredging-Expo.com.

WEDA gives precedence to presentations that are based on a technical paper that is peer-reviewed and published in our proceedings. WEDA publishes the meeting's proceedings for the membership to share and to further knowledge exchange in our industry. However, recognizing that providing a full paper is a barrier for some, we will be providing additional flexibility by accepting a limited number of presentations for which a full paper will not be mandatory. For these sessions, presenters may submit an extended abstract (2 pages) and their PowerPoint presentation. Both will be peer-reviewed and authors required to respond to reviewer recommendations to obtain approval for the presentation. Extended abstracts and PowerPoint presentations will have the same submission and review schedule as full papers. Final extended abstracts will be published as part of the meeting proceedings.
